TERM-TIME EMPLOYMENT FORM

NCAA Bylaw 15.2.6 states that earnings from a student-athlete's on- or off-campus employment that occurs at any time is exempt and is not counted in determining a student-athlete's full grant-in-aid or in the institution's financial aid limitations, provided:

- a) The student-athlete's compensation does not include any remuneration for value or utility that the student-athlete may have for the employer because of the publicity, reputation, fame or personal following that he/she has obtained because of athletics ability;
- b) The student-athlete is compensated only for work actually performed; and
- c) The student-athlete is compensated at a rate commensurate with the going rate in that locality for similar services.

However, before a University of Notre Dame student-athlete may secure employment and begin working, the below form must be completed in its entirety and submitted to the Athletics Compliance Office for approval. No student-athlete may have a job during the academic year before receiving approval from the Athletic Compliance Office. Failure to obtain Athletic Compliance Office approval could result in the temporary or permanent loss of athletics eligibility.
